

The Conjoint Bachelor of Commerce and Science (BCom/BSc – 540 points)

1. Version

2. Variations

In accordance with the Memorandum of Understanding between the University of Cape Town and the University of the Western Cape, the following regulations apply to the Conjoint Bachelor of Commerce and Science programme.

3. The structure of the qualification

The qualification is a Conjoint Bachelor of Commerce and Science, a student must

()

- v. the requirements for the Bachelor of Commerce, as set out in Schedule S of the Conjoint Bachelor of Commerce and Science Regulations.
 - v. the requirements for the Bachelor of Science, as set out in Schedule S of the Conjoint Bachelor of Commerce and Science Regulations.
- (c) be credited with a minimum of 20 units of courses in Schedule V of the Conjoint Bachelor of Science Regulations.
- . the student must be at least 100-level and
 - . the student must be at least 300-level and
 - . complete the courses listed in Schedule C of the Conjoint Bachelor of Science Regulations.
- v. the requirements for the Bachelor of Science, as set out in Schedule S of the Conjoint Bachelor of Science Regulations.

4. Admission to the qualification

The admission requirements for the Conjoint Bachelor of Commerce and Science are:

- () the student must be registered in the University of Cape Town.
- (x) the student must have completed the following requirements:
- . completed the first year of the Bachelor of Science programme at the University of Cape Town (UC) or the University of the Western Cape (UWC).
 - . completed the first year of the Bachelor of Commerce programme at the University of Cape Town (UC) or the University of the Western Cape (UWC).
 - . completed the first year of the Bachelor of Science programme at the University of the Western Cape (UWC) and the first year of the Bachelor of Commerce programme at the University of Cape Town (UC).

5. Subjects

The student must complete the following subjects in the Conjoint Bachelor of Commerce and Science programme:

6. Time limits

The student must complete the Conjoint Bachelor of Commerce and Science programme within a maximum period of 40 units.

7. Transfers of credit, substitutions and cross-credits

The student must complete the Conjoint Bachelor of Commerce and Science programme within a maximum period of 40 units.

- (x) the student must complete the Conjoint Bachelor of Commerce and Science programme within a maximum period of 40 units.

8. Progression

This qualification adheres to the Credit Recognition and Transfer Regulations of the following institutions:

- () student requires permission from the University of Waikato Business Degree re-enrolment conditions in the first semester and must maintain a cumulative GPA of 4.0 each semester to qualify.
- (x) student must enrol in the necessary degree each year unless they re-enrol in the necessary degree within the same semester.
